- 1. To propose a roadmap for establishment of structure and nature of Special Purpose Vehicle (SPV) based on Request for Proposal (RFP), in consultation with Ernst & Young LLP, which has been engaged for providing Transaction Advisory, Investment Promotion for Development of Theme/ Amusement Park in J&K.
- 2. To study the Site Assessment Report (SAR), Theme Park Bench-marking Study Report, Investment Promotion Strategy, Project Structuring, Project Procurement, and Project Management Structure to be prepared by Ernst & Young LLP.
- 3. To study and recommend upon draft bid document, issuance of RFP, evaluation of RPF for selection of concessionaire and signing of concession agreement.
- 4. To act as a recommending body to place the proposals for accord of sanction of the respective competent authority, throughout the project, as and when required.
- 5. To deliberate and take a decision on any concomitant issue in the context of the successful execution of the project.
